

Resolution for Adoption by the Board of Education of Almont Community Schools

General Appropriation Resolution

RESOLVED, that this resolution shall be the general appropriation of Almont Community Schools for the 2020-21 fiscal year; a resolution to make appropriation s; to provide for the expenditure of the appropriations; and to provide for the disposition of all revenues received by Almont Community Schools.

BE IT FURTHER RESOLVED, that the total revenues and unappropriated fund balance estimated to be available for appropriation in the General Fund of the school district for fiscal year 2020-21 which includes 18 mills of ad valorem taxes to b levied on non-homestead and nonqualified agricultural property to be used for the operating purposes as follows:

FURTHER RESOLVED, that no board of education member or employee of the school district shall expend any funds or obligate the expenditure of any funds except pursuant to appropriations made by the board of education and in keeping with the budgetary policy statement hitherto adopted by the board. Changes in the amount appropriated by the board shall require approval of the board.

BE IT FURTHER REOLVED, that for purposes of meeting emergency needs of the school district, transfers of appropriations may be made upon the written authorization of the superintendent but no other transfers shall be made without prior approval of the board of education. When the superintendent makes a transfer of appropriations as permitted by this resolution , such transfer shall be presented to the board of education at it s next regularly scheduled meeting in the form of an appropriation amendment, which amendments shall be adopted by the board of education at such meeting.
